# Instructions to Club Presidents, Sec

1. CLUB DUES: Your club dues for 2019 must be paid up to date to qualify as voting delegates for the Convention. We suggest that you check with your treasurer to make sure these dues have been paid prior to registering.

2. PROXY VOTES: All proxies must be signed and returned to the MUCC office before **June 12, 2019**. A club will not be permitted to vote if affiliate dues are not paid up to date, this includes proxies. No proxies or credentials will be transferred at the Convention except in case of extreme emergency or illness, such as determined by the Executive Board.

**3. CLUB DELEGATES: Please bring this agenda with you to convention. Additional copies will not be made available at the convention site. A full book is available at <https://www.mucc.org/mucc-annual-convention/>.**

4. PREREGISTRATION: Preregistration information has been included in this Convention Agenda. You will find the appropriate forms needed to pre-register and a return addressed envelope for your convenience. Your materials will be available at the convention site. **YOU ARE ENCOURAGED TO PREREGISTER TO AVOID DELAYS AT CONVENTION.**

5. REGISTRATION: If you do not preregister, voting delegates must bring their completed voting forms with them to the convention registration desk. These forms were mailed to the club president and/or club representatives. No delegate will be allowed to vote without authorization from the club officers. You may not use any cards other than your own to vote. **AN ADDITIONAL \$ 15 FEE WILL BE INCURRED FOR REGISTERING AT THE DOOR.**

6. THE CLUB AUTHORIZATION FORM must be signed by not less than two officers of the affiliate club. (Please review the agenda on the following pages with your voting delegates so they know your club's decisions and vote accordingly at Convention.)

7. THE ATTENDEE REGISTRATION AND VOTING DELEGATE FORM must be filled out showing the total number of club votes, proxy votes and if the member is entitled to an officer or MUCC Past President vote.

# Secretaries and Convention Delegates

8. THE CLUB NAME AND NUMBER: Please remember to fill in your club name and number wherever requested.

9. EMERGENCY RESOLUTIONS are considered under New Business. Items shall be restricted to emergency resolutions and only those emergency resolutions not considered at a prior MUCC Conservation Policy Board meeting. To be considered as an emergency, such proposal or resolution shall deal with an issue that must be considered prior to the next Executive Board meeting following convention due to time limitations. No more than two (2) proposals under new business shall be presented by any member or member club at the Annual Convention and considered as new business and must be affirmed by a two-thirds (2/3) vote of delegates present and voting. A total of 175 copies must be made available for distribution and a copy made available on a CD or flash drive to be given to the recording secretary. MUCC President George Lindquist must receive 15 copies as soon as possible.

10. VOTING FOR OFFICERS will take place on Saturday, June 22 from 5:30 - 6:30 pm. Voting will re-open Sunday, June 23 from 7:30 a.m. - 8:30 a.m.

11. To expedite the annual meeting and accuracy of resolution amendments, it is required that you use the resolution amendment form in the back of this book. Additional copies will be available on the information table at the convention site.

On the reverse side you will find the Club Authorization Form. Rather than requiring each voting delegate to have their own Voting Authorization form signed, we request that an MUCC club representative complete **ONE (1) Club Authorization form for all of your club's voting delegates and return it to MUCC by mail or email.**

### INSTRUCTIONS:

1. Write the name of your club on the line provided.
2. Write the county in which your club resides on the line provided. If your club does not have a physical location, this should be the county of residence for the main club contact. Write the corresponding MUCC region (see map).
3. Write the address, city, state, and zip code of your club on the lines provided.
4. Provide the phone number and email address of your club or MUCC club representative.
5. List the names and distribution of your club's votes to voting delegates. It is up to you to determine how you would like the votes distributed. If you do not indicate how you would like the votes distributed, the Credentials Committee will distribute them as evenly as possible among your authorized delegates. The number of votes to which your club is entitled is based on dues paid by Records Day. A table with the number of club members and corresponding number of votes is provided at the bottom of the form.
6. Two (2) club officers are **required** to sign the form prior to submission in order to authorize voting delegates to vote for your club.
7. If your club is unable to send club delegates, but would like to send your votes with a proxy voter, please indicate the person who will vote for your club at the bottom of the form. A proxy voter is someone who is not a member of your club to whom your club authorizes to vote on your club's behalf. Each club can send up to one (1) proxy voter. If you are planning to send your votes with a proxy voter, the Club Authorization form **MUST BE RECEIVED NO LATER THAN JUNE 12, 2019 — NO EXCEPTIONS.**
8. Mail or email the Club Authorization form to the address or email address provided on the form.

## *Rules*

- A. ROBERT'S RULES OF ORDER SHALL BE THE AUTHORITY ON CONVENTION PROCEDURE.
- B. ALL VOTING WILL BE BY VOICE UNLESS OTHERWISE REQUIRED. A SHOW OF HANDS OR A ROLL CALL VOTE MAY BE ORDERED BY THE CHAIR FOR ACCURACY.
- C. ONLY VOTING DELEGATES MAY BE SEATED IN THE DELEGATES VOTING SECTION.
- D. ONLY REGISTERED VOTING DELEGATES MAY VOTE OR MAKE/SUPPORT MOTIONS.
- E. VOTING DELEGATES MUST WEAR BADGES AND CARRY VOTING CARDS INDICATING THE NUMBER OF VOTES CARRIED.
- F. RESOLUTIONS TO CHANGE THE BYLAWS REQUIRE A 2/3 VOTE.
- G. RESOLUTIONS TO CHANGE STATE OR FEDERAL LAW OR RULES OR NATURAL RESOURCES COMMISSION ORDERS REQUIRE A 2/3 VOTE.

## *Amendments*

LENGTHY AMENDMENTS (MORE THAN A FEW WORDS, TYPOS OR SIMPLE EDITORIAL CORRECTIONS EXCEPTED) SHOULD BE SUBMITTED ON THE "RESOLUTIONS AMENDMENT FORM" (AVAILABLE AT THE ANNUAL MEETING) WITH A COPY, OR THE ORIGINAL, SUBMITTED TO THE RECORDING SECRETARY. THE AMENDED RESOLUTION WILL THEN BE DISPLAYED ON A SCREEN FOR ALL TO REVIEW.

## *Procedure for Testimony on Resolutions*

- 1. THE SPONSOR OR SPONSORING CLUB OF A RESOLUTION HAS FIVE MINUTES TO EXPLAIN THE RESOLUTION AND ADVOCATE FOR ITS PASSAGE.
- 2. TWO MICROPHONES, DESIGNATED SUPPORT OR OPPOSED, WILL BE AVAILABLE. SPEAKERS MUST USE ONE TO BE RECOGNIZED FOR DISCUSSION AND THEY WILL SPEAK ALTERNATELY. PLEASE USE THE APPROPRIATE MICROPHONE FOR YOUR POSITION (SUPPORT OR OPPOSE) ON THE ISSUE.
- 3. ALL MEMBERS HAVE THE OPPORTUNITY, IF SO INTERESTED, TO SPEAK FOR TWO MINUTES FOR OR AGAINST A RESOLUTION.
- 4. MEMBERS MAY TESTIFY TWO TIMES ON A RESOLUTION. A TWO-THIRDS VOTE OF THE DELEGATES IS REQUIRED FOR A PERSON TO TESTIFY MORE THAN TWO TIMES.
- 5. MUCC'S PARLIAMENTARIAN (OR THEIR AUTHORIZED REPRESENTATIVE) WILL KEEP TRACK OF THE TIME OF EACH TESTIFIER TO ENSURE THE TIME LIMITS ARE NOT EXCEEDED.
- 6. MEMBERS ARE ENCOURAGED TO NOT DUPLICATE TESTIMONY AND TO STRUCTURE THEIR TESTIMONY TO INCREASE THE UNDERSTANDING OF THE CONVENTION AUDIENCE ON THE ISSUE.
- 7. A MOTION, AND A SECOND, TO BRING A RESOLUTION TO THE FLOOR WILL NOT REQUIRE USE OF THE MICROPHONES. PLEASE STATE YOUR NAME CLEARLY.
- 8. SPEAKERS MUST IDENTIFY THEMSELVES WITH THEIR NAME, CLUB NAME OR MUCC TITLE EACH TIME THEY USE THE MICROPHONE FOR ACCURATE RECORDING BY THE RECORDING SECRETARY.

#### **B. Acceptance of Application for Affiliation**

All applications for affiliation as a Member Club, **or** Junior Member Club, **or** Statewide Affiliate Club, **OR SUS-TAINING MEMBER** shall be subject to the approval by the Executive Board. The Executive Board shall approve or disapprove the class designation and designate the Region in which the club will belong. A Statewide Club may be assigned to a Region representing Statewide Affiliate Clubs and those Member Clubs with a statewide mission and membership composed of geographical representation of the state or a Region on the basis of their club's primary location or mailing address of record. **Title: EXECUTIVE BOARD**

**Purpose:** To adjust the number of members required to be at a meeting to constitute a quorum for official transaction of business.

The number now required is based on the full number of officers as allowed by the bylaws (17). Two of these members (appointed At Large Directors) are appointed by the President if he/she can find someone that will agree to the appointment. The idea behind these appointments is to find someone with an area of expertise (law/finance/real estate/etc.) that would be of extra benefit to the Executive Board. If these appointments cannot be made, it lowers the number of officers that can be attending a meeting (15). This puts the Executive Board in a position of not having a quorum of more than 3 members are not able to make a meeting. There was at least one instance last year where we could not conduct business because we did not have a quorum due to vacancies.

To assure a reasonable expectation of having a quorum at all meetings, the Executive Board is proposing to lower the quorum requirement to 10 members.

### **Summary of resolutions passed, failing, and postponed at MUCC's 2017 Annual Convention**

#### **PASSED RESOLUTIONS**

**#02: BEAR BAITING WITH BARRELS:** MUCC work with the Department of Natural Resources (DNR) and the Natural Resource Commission (NRC) to allow the use of bait barrels on public property in Michigan.

**#03: ALLOW HUNTERS TO POSSESS AND USE BOTH A CROSSBOW AND LEGAL FIREARM, SIMULTANEOUSLY, WHILE HUNTING DEER DURING THE DECEMBER MUZZLELOADER AND LATE ANTLERLESS SEASONS (EXCEPT THE UPPER PENINSULA DECEMBER DEER SEASONS:** MUCC work with the Department of Natural Resources (DNR) and the Natural Resources Commission (NRC) and frame a Wildlife Order that would eliminate certain, conflicting or contradictory statements and confusion from the Hunting Digests, along with removing the prohibition against possessing and using a crossbow and legal firearm, simultaneously, during the December firearms seasons (except in the U.P.); and MUCC, the DNR and NRC work out the hunter orange requirements the above changes would create, along with aligning the elements of the December firearms deer seasons with those presently enjoyed by hunters during the November deer season.

**#04: SANDHILL CRANE HUNTING (GRUS CANADENSIS):** MUCC work with the Michigan Department of Natural Resources, the U.S. Fish and Wildlife Service and anyone else to establish a Sandhill Crane Hunting Season in the State of Michigan by unit.

**#05: DESIGNATE MOURNING DOVE AS A GAMEBIRD:** MUCC work with the Michigan Legislature to eliminate the unnecessary restrictions on the Natural Resources Commission in naming game species; and that the Michigan Natural Resource Commission and Michigan's wildlife biologists use sound science to once again designate the mourning dove as a gamebird.

**#06: DEVELOPMENT OF A SHORT TERM (7 DAY) NON-RESIDENT WATERFOWL LICENSE SYSTEM:**

MUCC work with the Michigan Department of Natural Resources, the Michigan Legislature and waterfowl conservation groups to provide for a short term non-resident waterfowl license system; and that MUCC explore and develop legislative changes to implement a short term non-resident waterfowl license system.

**#07: MICHIGAN PHEASANT RELEASE FOR HUNTER RECRUITMENT:** MUCC work with the Michigan Legislature, Department of Natural Resources (DNR), and the Natural Resources Commission (NRC) to support the Michigan Pheasant Release for Hunter Recruitment with the mission, goals, and outcomes indicated.

**#08: TREESTAND SAFETY:** MUCC use its communication assets to educate hunters about the risks of hunting from a treestand without a fall arrest system/full body harness.

**#09: REINTRODUCTION OF LAKE HERRING (CISCO) IN SAGINAW BAY:** MUCC work with and urge the Michigan Department of Natural Resources and any other agency, committee or group to get the Lake Herring (Cisco) reintroduced into Saginaw Bay, Lower Lake Huron.

**#10: RESEARCH IMPACTING FISHERIES AND ANGLER EXPERIENCE:** MUCC work with the Department of Natural Resources (DNR) and the Michigan Legislature if needed to implement a fisheries research policy that would:

- Engage sport fishing and conservation interests in scoping the needed research projects;
- Seek to avoid or reduce conflict with major seasonal runs of sport fish;
- Consider maintaining angler access to the maximum extent possible during the research period;

And that MUCC recommends DNR only use of resistance board weirs for research purposes if 1) the project development has included public input from anglers and others who may be impacted by the study and 2) that the benefits of the research outweighs the impact that research may have on the local non-target fisheries populations and recreational users.

**#11: "SURPLUS" STATE OF MICHIGAN-OWNED PUBLIC LAND DISPOSAL PROCESS:** MUCC oppose any legislation or other Department of Natural Resources administrative activities which would allow for the sale or exchange of State of Michigan-owned or managed lands greater than 80 acres in size, or parcels which would restrict public riparian access without having been previously designated as "Excess" or "Surplus" from a published list which has been developed through a transparent process which includes a local and regional Departmental review, as well as a public comment or engagement process.

**#12: UNFUNDED MANDATES ON THE MICHIGAN DEPARTMENT OF NATURAL RESOURCES:** MUCC oppose or seek to amend any legislation which requires the expenditure of Michigan Department of Natural Resources funds for tasks or functions which may result in a diversion of hunting and fishing license revenue or funding whose use may otherwise be restricted, and that any such legislation should include the appropriation of the necessary supplemental funding in an effort to avoid such a diversion before it would be supported MUCC.

**#13: BRINGING CERVID CARCASSES INTO MICHIGAN FROM OTHER STATES:** Michigan adopt a stance that Minnesota, Montana and other states have adopted in that any cervid, (deer, moose, elk,...) carcass brought into Michigan (whether taken from a wild or captive population) be in the form of deboned meat, clean skullcap, finished taxidermy, and/or other parts not anticipated to carry CWD prions; and that the Michigan Legislature work to increase the fines and penalties for violations of this whole carcass prohibition; and that the United States Fish and Wildlife Service and other federal agencies as necessary, with support from the Michigan delegation of U.S. Senators and U.S. Representatives, work to make the prohibition of carcass movement a federal regulation.

**#14: CAPTIVE CERVID REGULATION REFORM:** MUCC work with the Michigan Department of Agriculture and Rural Development, the Michigan Department of Natural Resources, U.S. Department of Agriculture Wildlife Services, Quality Deer Management Association, and other interested parties, to reform captive cervid

facility regulations to reduce the chance of Chronic Wasting Disease transmission between captive cervid facilities and the wild deer herd. These regulatory reforms shall include, but not be limited to:

- establishing double fencing to reduce opportunities for transmission through the fence,
  - a mandatory supervised testing process to eliminate opportunities for illegal substitution of deer for testing from outside the facility,
  - a state funding mechanism that would provide adequate funding for Chronic Wasting Disease surveillance and response both inside and outside of captive cervid facilities,
  - improved cervid facility record keeping requirements,
  - non removable cervid tagging,
  - oversight of cervid transportation,
  - a 30-day maximum period for depopulating an infected facility once the decision has been made to do so,
- and
- improved enforcement mechanisms,

and that these policies are intended to supplement the 2010 MUCC policy that requests that an immediate moratorium on new captive cervid facilities, imposes a strict schedule for expiration of registrations of facilities not in compliance, and limits future registrations to and by renewal, transfer, or sale of current registrations.

**#15: SUPPRESSOR TAX ELIMINATION:** MUCC works with the Michigan delegation of U.S. Senators and U.S. Representatives to remove regulations for suppressors from the National Firearms Act of 1934; and that MUCC work with our U.S. and state legislature to allow the purchase of a suppressor to follow the same guidelines currently in place to purchase firearms through the NICS (National Instant Criminal Background Check System) program; and that MUCC supports suppressors being eligible for the Pittman Robertson excise tax.

**#16: STATE OWNED MINERAL EXCHANGES AND PURCHASES TO PROTECT PUBLIC LAND:** MUCC urges the Michigan Department of Natural Resources to make it a priority to acquire severed minerals where the State owns the surface only to protect and control the commercial use of public land; and that the highest priority should be given to minerals in State Parks and lands purchased with PR and Game and Fish Funds.

**#17: REINSTATE CORMORANT CONTROL:** MUCC work with the U.S. Fish and Wildlife Service to reinstate the Public Resource Depredation Order on cormorants; and that MUCC work with our U.S. Representatives and U.S. Senators to come up with a law to reinstate cormorant control.

## **FAILED RESOLUTIONS**

**#01: YOUTH HUNTER SUPERVISION:** MUCC work with the Michigan Legislature, Department of Natural Resources (DNR), and the Natural Resources Commission (NRC) to institute the following: On private land only, a minor who is at least 14 years old shall be permitted to hunt within a distance no greater than 660 feet from the parent or legal guardian which permits uninterrupted electronic communication and allows the parent or legal guardian to come to the immediate aid of the youth. The youth hunter MUST have completed all of the following criteria:

- has successfully completed a certified hunter safety program,
- has been properly licensed and been supervised hunting for at least 20 hours in each of the immediately preceding two hunting seasons
- the parent or legal guardian of the youth hunter must submit a signed affidavit at the time of the youth hunter's license is purchased stating that the applicant has completed at least 20 hours of supervised hunting in each of the immediately preceding two hunting seasons and that the youth hunter was properly licensed in the immediate two preceding seasons.

Eichinger then presented the Annual Report, emphasizing where the organization has come from and where we hope to see it in the next 80 years. Eichinger reported that our membership is stable, we have stabilized revenues and expenses, leveraged new funders and fund sources to diversify where our revenues come from and have directed it to program and mission related work. Our administrative processes are improving, our education programs are growing and expanding rapidly. OTG has expanded to include classroom components. MUCC has our new editor who will take Michigan Out-of-Doors to new levels. Our policy and advocacy agenda is on track and deeply impactful. MUCC has participated in a variety of workshops and committees including: Blue Ribbon Panel on State Game Areas, Boone and Crockett Club, Michigan's R3 Coalition, among various others. MUCC will be taking on a comprehensive, ambitious and aggressive strategic plan.

PPP: Jack VanRhee stated that he brought posters of the Conservation Pledge for members to hang in their clubs and so forth.



**Announcements:**

Heritier announced lunch will be served in the conference room and thanked Dan and MUCC staff for their commitment to the organization and mission and asked the audience to stand and join him in applause for all of their hard work.

-----**Convention was recessed for the Luncheon**-----

Session came back to order at 1:57 p.m.

Heritier introduced Dr. Russ Mason, Chief of the DNR Wildlife Division before he gave his address on behalf of Keith Creagh, the DNR Director.

**Director Address:** Mason thanked MUCC for the work they accomplished in helping secure \$1 million for the fiscal year for CWD surveillance and work. Mason spoke on the relevance of conservation in Michigan. The GUD Marketing strategy that the DNR did over the previous year proved that the public is out of touch with the nature of the hunting, trapping and angling community. We need to be thinking carefully about how we develop coalitions for these natural resources, and how we reach out in recruitment and retention efforts, these coalitions should be broad and inclusive. The DNR over the last year has developed a whole variety of programs including a wetland restoration/mitigation banking. Mason also spoke on the concerns of CWD. At this point 13,000+ deer have been tested, 9 have been confirmed positive to date. 324 deer have been removed from Mecosta County, and about 70% of the ones tested have been through sharp shooting. This fall there will be a symposium in Lansing, focused on CWD. Mason spoke briefly on wolves, moose, cormorant and Sandhill cranes. Mason offered to answer questions at the conclusion of his speech.

Heritier thanked Dr. Mason and indicated proposed policy resolutions were next on the agenda and an update from the Credentials Committee.

Yeager, Past President, Chair of the Convention Credentials Committee gave an update for the Credentials Committee: Currently have 293 votes.

Heritier mentioned during the break that he was approached by someone to move Resolution #07 forward because they have to leave Convention early.

Launched in the fall of 2016 MUCC and partners have commissioned MSU to complete a study on the value of hunting and fishing and local regional levels. Eichinger answered questions at the conclusion of his special presentation.

**Summary of resolutions passed, failing, and postponed at MUCC's 2018 Annual Convention**

#### **PASSED RESOLUTIONS**

**#01: ADEQUATELY FUND UNITED STATES FOREST SERVICE, NATIONAL PARKS, AND NATIONAL MONUMENTS AND REDUCE TORT LIABILITY (Tim Kobasic, Hiawathaland Trail Association and Straits Area Sportsmen's Club):** MUCC calls on Congress to amend the budget of the USFS to help offset the costs of fire suppression and help them maintain their fundamental services. MUCC would also ask Congress to pass legislation that will assure the USFS and their sponsors adequate funds in the event of a lawsuit from those that use the National Forests for recreation. Lastly, ensure that all National Forests, Parks, and National Monuments remain intact and continue to allow public access.

**#03: ESTABLISH REGULATIONS ON THE OPERATION OF WAKE BOATS (Diane Konneck, Individual Member):** MUCC will work with the legislature, DNR, and NRC to create regulations restricting the use of boats that produce a wake large enough to surf or wakeboard to larger lakes and areas further from the shore than the current rules allow.

**#04: MUCC WORKING CLOSELY WITH THE DNR IN THE MANAGEMENT OF CWD, TB, AND OTHER DISEASES (Erik Schnelle of QDMA, and Rob Miller):** MUCC will bring the issue of CWD and TB to the forefront and work with the DNR to enforce existing laws, find alternative funding other than what is provided by existing fish and wildlife funds and continue education efforts and promote hunter involvement in combating these diseases. MUCC also supports additional harvesting of does in DMU's through methods of later seasons and reduced doe tag prices and other means to help promote the take of does to maintain a balanced herd. MUCC continues to support baiting bans. MUCC should work with QDMA and other stakeholders to help DNR and NRC with this disease.

**#05: LINE 5 AND ALTERNATIVES TO UNDERWATER PIPELINES (Saginaw Field and Stream Club):** MUCC will work with the National Wildlife Federation and other decision makers to protect the Great Lakes from any oil spill, including serious considerations of alternatives to pipelines across or below the Great Lakes.

**#07: DAILY PERCH HARVEST RULES TO BE EXPANDED (George Lindquist, MUCC Vice President):** MUCC will work with the DNR and the NRC to make the regulations for yellow perch in Lake Gogebic, which includes a 25-perch bag limit with no more than five fish 12" or greater, a rule for state inland lakes and wherever else appropriate.

**#09: IMPROVING NO NET LOSS OF HUNTING LAND (UP Whitetails of Marquette County):** MUCC will work with the Michigan Legislature, the DNR, and the NRC to ensure that the amount of public land available to hunters does not decrease in the future and that if state managed public hunting land does close, there will be compensation in the form of new hunting land in the same region for fair opportunities to hunters in those regions.

**#11: RESOLUTION DIRECTING THE MICHIGAN DEPARTMENT OF NATURAL RESOURCES (DNR) TO CREATE A COMPREHENSIVE MOOSE MANAGEMENT PLAN (Greg Peter, MUCC At Large Director):** MUCC encourages the DNR to create a moose management plan understanding the need of additional funds and personnel to ensure a sustainable moose population that supports hunting as a management tool.

**#13: FIREARMS EDUCATION AND SAFETY (David Van Lopik, Sport Shooting Committee Chair):** MUCC will work with the State Department of Education, Intermediate School Districts, and local school districts to provide access to promoting, advertising and providing information about firearm safety classes and hunter education classes at local, regional and state facilities and other range facilities open to the public.

**#15: MICHIGAN ARCTIC GRAYLING STOCKING INITIATIVE RESOLUTION (Paul Rose, MUCC Past-President):** MUCC and its partners will work with the DNR to ensure the introduction of Arctic Grayling to Michigan rivers will only be done if: The management of existing fisheries will not be affected by a change in legal status of Arctic Grayling such as "threatened" or "endangered" under the Endangered Species Act elsewhere in the United States; the planting of Arctic Grayling will only occur in water bodies where support exists from stakeholders and anglers; and if the funding of an Arctic Grayling program is confirmed to be sustainable and will not undermine existing fisheries programs or staffing in Michigan.

**#16: PROTECTING LIVESTOCK FROM BEAR DEPREDATION (Tim Dusterwinkle, Michigan Bear Hunters Association):** MUCC will work with the Michigan Legislature to amend state law to require an electric perimeter fence on privately-owned cervid operations to deter bears and other species such as coyote and wolf.

**#17: ORV USE IN THE STATE FOREST (MUCC Parks, Recreation and Trails Committee):** MUCC will urge the DNR to develop an annual public report that provides data on ORV damage, enforcement activity and accidents in the state forest. Also, MUCC should request that the DNR not allow expansion of forest roads open to ORV unless the ORV report is posted for public review and evaluated for: compliance with the DNR's forest certification criteria; the ability of DNR to mitigate resource damage; and adequate funding of ORV enforcement is in line with the expansion of ORV use on forest roads.

**#19: ESTABLISH DESIGNATED WATER TRAILS PROGRAM (MUCC Parks, Recreation and Trails Committee):** MUCC urges the DNR to finalize the draft "Michigan's Policy on State Trails Designation" and implement the designation program.

**#20: WANTON AND WASTE LAW PERTAINING TO WHITETAIL DEER (Daniel L. McMaster, Shiawassee Conservation Association):** MUCC will work with Quality Deer Management Association (QDMA), Whitetails Unlimited (WTU), the DNR, the NRC, and the legislature to create and adopt wanton waste legislation pertaining to whitetail deer to ensure there are penalties if no reasonable attempt is made to retrieve the animal. This should also ensure the carcass of a deer should be disposed of properly and not left in the field. It is recommended that MUCC also consider wanton waste laws for other game species.

**#21: WORK WITH THE DNR TO EXPAND PUBLIC ACCESS TO THE DETROIT RIVER AND LAKE ST. CLAIR BY CONSTRUCTING A PUBLIC BOATING ACCESS SITE ON BELLE ISLE (Tim Muir, Lake St. Clair Walleye Association):** MUCC reaffirm its commitment to expanding fishing opportunities in the Detroit River and Lake St. Clair by supporting the DNR, Belle Isle Conservancy, and Belle Isle Park Advisory Committee with the construction of a tournament friendly, 24 hour/day boating access site on Belle Isle. Also, ask that the DNR work with the fishing tournaments and local fishing conservation clubs to review and consider the positive local economic benefits associated with building a tournament friendly boating access site that will help to host organized fishing events.

**#22: ESTABLISH WORK ORDERS TO REQUIRE PARKS TO CO-OPERATE WITH OTHER DIVISIONS ON HABITAT MANAGEMENT (MUCC Parks, Recreation, and Trails Committee)**  
MUCC will work with the DNR to establish work orders to require the Parks and Recreation division to cooperate with the other divisions of the DNR to address the needs for managing wildlife habitat located within the State Parks and State Recreation Areas.

**#23: PASSED: RESOLUTION ON THE VALUE OF PUBLIC LAND (Michigan Resource Stewards):** MUCC will work with Michigan Resource Stewards to urge our legislature, advocacy groups, and policy makers at all levels to support the efforts of the DNR, MSU, and others to document the value and value added to our economy by public land and acknowledge the multiplicity of health benefits, social benefits and other intangible benefits that accrue to Michigan citizens because of our public lands.

#### **WITHDRAWN RESOLUTIONS**

**#06: Combine both of the spring turkey season in hunt ZZ into one six-week season (Millard H. Holton, Individual Member)** MUCC would work with the DNR and the NRC to frame a Wildlife Order that would combine the existing Hunt Unit ZZ turkey seasons (April 2-week season and guaranteed hunt in May) into one which would increase hunting opportunities as well as recruit and retain more hunters.

#### **FAILED RESOLUTIONS**

**#02: Antler Point Restrictions (APR) Initiative Acceleration (Erik Schnelle of QDMA, and Rob Miller):** MUCC should advocate for the acceleration of the Antler Point Initiative process to take no more than one calendar year from the date of initiation to regulation. Also that the APR initiative process should be conducted at no cost to the sponsoring sportsmen group's.

**#08: Reduce the number of buck tags per hunter to one per year (Charles Felcyn, Paw Paw Conservation Club):** MUCC will work with the DNR and the NRC to simplify and restructure the deer combo license to include one buck tag and one doe tag. For those hunters only wishing to hunt in the UP, they would have the option of just buying a single deer tag for an antlered deer.

**#10: Change opening day of firearm deer season to the Saturday closest to November 15th (Leonard Shaner, Huron Pointe Sportsmen’s Association):** MUCC would urge the DNR and other appropriate public entities to examine the economic, social, natural resource, and hunter recruitment implications that would result from changing the opening day of Michigan firearm deer season to the closest Saturday to November 15th. If this review results in a recommendation of this change, then MUCC would support this initiative.

**#12: Center fire changes to Michigan's limited firearm zone (Charles Felcyn, Paw Paw Conservation Club):** MUCC work with the DNR and the NRC to change Michigan’s limited firearm deer zone to have the same firearm restrictions and regulations as the rest of Michigan.

**#14: Bobcat license (Tim Dusterwinkle, Michigan Bear Hunters Association):** MUCC work with the Michigan Legislature to create a bobcat license for a reasonable fee that will recognize bobcats as a premier game species while recouping some DNR costs for their management.

**#18: Primitive archery season extension from one day after the liberty hunt through January 31st (Sam Morello, Michigan Bow Hunters Association):** MUCC should work with the DNR and the NRC to allow a Primitive Archery equipment season with a start date being the first day following the Liberty Hunt and continue the season until January 31st of the following year.

Communications is key. We always need improvement on this in our personal lives and in governance. MUCC from Pontz perspective. She was the driver of the cornfield and she wanted to hunt instead. Learned about the connection of agriculture and natural resources early on, organic gardening, hunting, conservation practices. She started at Farm Bureau with grassroots development of policy. And it’s difficult to maintain a strong single voice while appreciating the diversity. MUCC is very similar. She has seen how difficult it can be with single species and single device interests. You are the conservation voice with a 30,000 foot view. You have to consider the impact 7 generations from now. Our process matters. Consideration of governance from UN. MUCC is part of it too. Structures and process

The world is run by those who show up. Thank you for showing up.



## **Eichinger introduced Director Creagh**

### **Director Address:**

We have changed our governance model. We want your opinions on the front end and to come up with joint solutions. Transparency and credibility in organizations.

Budget is increasing General Fund-Law, Fire, license fee increase and focus on outcomes. Belle Isle funding is a partnership of local and state government. Great lakes vessel. Invasive Species 5 million from GF. \$40 at Brandon Lock and Dam, 92 percent agreement within the basin. Iron Belle Trail, goes through state land, but should it be a conversation. Shooting ranges used to be a 2 week a year use, partnering with NRA and others on structured shooting areas on state land. Wetland conservation and mitigation.

Looking ahead: urban initiatives, R4-relevancy—related everything back to natural resources, scientific management, and wild game. Invasive species, land strategy, asset management for State Parks, hatcheries, 4000 structures, State Park Endowment Fund shouldn't be used for operations, it should be longer term and new acquisitions.

Wildlife Disease is going to be difficult. No one knows all the answers. Jackson County could be expanded. Need thoughtful conversations about managed disease—we have managed recreation, and hunter satisfaction. HPAI—we shouldn't have a goose relocation program. Incentivize doe harvest and get the numbers more reconciled on the landscape. It will not be universally acceptable but there is a good process in place.

Pretty optimistic—5.3 million for research, 600k is committed. Boone and Crockett and nationally having conversations. \$25 for the test \$100 for confirmation. How do we pay for that?

- Lindquist took over as chair and shared his excitement to take over as President. He thanked everyone and encouraged them to continue to volunteer and keep our organization moving and growing.

### **Treasurer's Report**

1 **WHEREAS**, Chronic Wasting Disease (CWD) is an invariably fatal disease of a highly infectious nature,

3 **WHEREAS**, left unchecked, CWD has been shown to not only decimate deer populations as the  
4 incidence climbs inexorably higher, but CWD also depress the age structure of the population  
5 significantly, and  
6 **WHEREAS**, the possibility of contracting the disease increases with age and the incidence risk level in a  
7 population increases with the deposition of prion in the environment, and  
8 **WHEREAS**, controlling CWD is complicated by this persistent environmental contamination with the  
9 responsible prion being shed from infected deer well before they show signs of infection, and

10 **WHEREAS**, the persistence of the prion in the environment results in an increased indirect transmission  
11 rate as the disease becomes endemic and the presence of infective prions increases with the density of the  
12 deer population, and

13 **WHEREAS**, direct transmission is also facilitated by concentrating the population on the landscape  
14 (density of susceptible deer) either by baiting or confinement, increases the risk of both direct and indirect  
15 transmission, and

16 **WHEREAS** in the CWD Management Zone, where current deer densities are high, current NRC/DNR  
17 regulations remove the antler restriction on the combo license in this first year to lessen the density of the  
18 deer population, and

19 **WHEREAS**, bringing down the density of the deer population in the CWD Management Zone is served  
20 by the revision of the combo license requirements to allow the harvest of more deer, and

21 **WHEREAS**, there is a consensus that management of transmission and contamination require the harvest  
22 of deer regardless of age or antler size to decrease the population density, and

23 **WHEREAS**, most all wildlife management strategies take several years to produce results that can be  
24 statistically measured and their efficacy in reaching goals confirmed, and

25 **WHEREAS**, to not continue that strategy for several years could confound the results of any changes  
26 (making it look more effective because of the first year's reduction of population density). NOW,

27 **THEREFORE BE IT RESOLVED**, MUCC encourage the continuance of the present strategy in the  
28 CWD Management Zone and any additional areas where the CWD threat is identified with surveillance,  
29 until sufficient data have been generated as to its effectiveness, and

1   **WHEREAS**, Chronic Wasting Disease (CWD) is an invariably fatal disease of a highly infectious nature,

3   **WHEREAS**, left unchecked, CWD has been shown to not only decimate deer populations as the  
4   incidence climbs inexorably higher, but CWD also depress the age structure of the population  
5   significantly, and  
6   **WHEREAS**, the possibility of contracting the disease increases with age in both sexes and the incidence  
7   risk level in a population increases with the deposition of prion in the environment, and  
8   **WHEREAS**, controlling CWD is complicated by this persistent environmental contamination with the  
9   responsible prion being shed from infected deer well before they show signs of infection, and  
10   **WHEREAS**, the persistence of the prion in the environment results in an increased indirect transmission  
11   rate as the disease becomes endemic and the presence of infective prions increases with the density of the  
12   deer population, and  
13   **WHEREAS**, direct transmission is also facilitated by concentrating the population on the landscape  
14   (density of susceptible deer) either by baiting or confinement, increases the risk of both direct and indirect  
15   transmission, and  
16   **WHEREAS** in the CWD Management Zone, where current deer densities are high, there are far more  
17   mature does than mature bucks, the harvest is heavily biased towards bucks rather than does, habitat  
18   damage to wood lots is extensive, and a lack of winter thermal cover and food results in large  
19   concentrations of deer, and the NRC/DNR has already passed a resolution to conduct scientific research  
20   to determine the best regulatory and management approaches to combatting CWD by reducing deer  
21   densities, reducing the age of the doe cohort, and better balancing deer harvest, and

22 **WHEREAS**, Yearling doe and buck dispersal in both spring and fall is a factor in the spread of CWD  
23 into new areas, and the timing, rates and distances of dispersal are made worse by high densities, lack of  
24 spring fawning habitat, and a scarcity of mature bucks, and

25 **WHEREAS**, in the current CWD area the deer harvest is not balanced and is heavily weighted towards  
26 young bucks, resulting in a herd that has far more does than bucks, does that are much older on average  
27 than the bucks, and increases in deer densities, and

28 **WHEREAS** effective disease management should focus on using current knowledge of deer behavior to  
29 reduce disease risk and ensure the harvest of the older deer that are most likely to be infected, that are  
30 spreading prions in the environment, and spreading the disease through social contact.

31 **WHEREAS**, there is an urgent need to determine the best deer and disease management strategies to  
32 fight CWD and this research may take several years to produce results that can be statistically measured  
33 and their efficacy in reaching goals confirmed, and

34 **WHEREAS**, in the scientific method the relative effectiveness of management approaches cannot be  
35 determined without the ability to compare competitive approaches and with a control group. and

36 **WHEREAS**, there are 16 counties in the current CWD area, with additional CWD detections in new  
37 areas likely to result in an even larger CWD management area, creating an opportunity to perform  
38 research into multiple competitive CWD management approaches and,

39 **WHEREAS** no state agency has tried a combination of regulatory changes to focus harvest on the deer  
40 most likely to be infected, with clear scientifically based doe harvest and testing goals set at a DMU level,  
41 with the goals explained to hunters prior to each season and progress towards those goals communicated  
42 throughout the deer seasons, and with habitat programs designed to reduce concentrations of deer and  
43 dispersal NOW,

44 **THEREFORE BE IT RESOLVED**, MUCC encourage and support the efforts of the NRC and DNR to  
45 perform research into determining the best CWD management approaches for Michigan's CWD  
46 Management Zones, and any additional areas where the CWD threat is identified with surveillance, until  
47 sufficient data have been generated as to its effectiveness, and

48 **BE IT FURTHER RESOLVED**, MUCC should stress the importance of population control and the role  
49 of the hunter/conservationist in this effort and encourage the issuance of additional doe permits and the  
50 establishment of doe harvest goals, where advisable, to decrease the density of susceptible deer, and  
51 **BE IT FURTHER RESOLVED**, MUCC remain involved in the design of any field studies in  
52 consultation with the biologists of the DNR and other wildlife disease authorities.

4 state-licensed commercial fishing regulations would aid in upcoming negotiations; and  
5 **WHEREAS**, There is a growing interest of commercial anglers to expand operations and harvest game  
6 species, in part due to the decline in whitefish populations, which have historically been the primary  
7 commercial fishery; and  
8 **WHEREAS**, the current commercial fishing license fees paid by commercial anglers do not pay for the  
9 cost of oversight, regulation or enforcement of their operations; and  
10 **WHEREAS**, the sale of hunting and fishing license fund the majority of the management of the fisheries  
11 and enforcement of regulations for both sportfishing and commercial use; NOW  
12 **THEREFORE BE IT RESOLVED**, that Michigan United Conservation Clubs works with the Michigan  
13 Legislature to enact legislation that will update commercial fisheries license fees to be commensurate  
14 with the oversight that is required of the commercial fisheries; and  
15 **BE IT FURTHER RESOLVED**, that this updated statute should make improvements in the program to  
16 be protective of the fisheries and sportfishing, including:

- 17 ● Protection of game species (except whitefish) from commercial harvest;
- 18 ● Governs how often commercial entities check their nets and regulates allowable gear in a manner
- 19 that also takes into account the time of the year and specificity of the net;
- 20 ● Creates or increases penalties for the disturbance of commercial fishing nets as well as the illegal
- 21 operations of commercial anglers; and
- 22 ● Requires appropriate markers for the location of nets and that these locations be available to the
- 23 public

4 required periodic renewal; and  
5 **WHEREAS**, Michigan United Conservation Clubs (MUCC) has historically represented the interests of  
6 the citizens of Michigan in the negotiations associated with these Treaty agreements as it relates to the  
7 taking of fish and game; and  
8 **WHEREAS**, the effective representation of these respective interests in past Treaty negotiations have  
9 occasionally caused these interests to be in conflict; NOW,  
10 **THEREFORE, BE IT RESOLVED**, that MUCC continue to promote and protect hunting, fishing and  
11 trapping opportunities in the State of Michigan while also seeking to improve relations with Michigan’s  
12 Native American Tribal members and leaders.

1 **WHEREAS**, Under current Michigan regulations (page 17 of the 2018 Michigan Hunting Digest), an  
2 artificial light may be used from November 1-30 on property you own or property owned by a member of  
3 your immediate family if you do not have in your possession or control a bow and arrow, firearm, or other  
4 device capable of shooting a projectile; and  
5 **WHEREAS**, It is a violation of federal law to shine at any time on any national wildlife refuge; and  
6 **WHEREAS**, Deer hunters may use an artificial light one hour before and one hour after shooting hours  
7 while carrying an unloaded firearm or bow and arrow when traveling on foot to or from their hunting  
8 location;  
9 **WHEREAS**, many hunters, particularly public land hunters, must travel to their hunting location much  
10 earlier than one hour before shooting hours in order to secure their spot and also to minimize wildlife  
11 disturbance and would benefit from being able to use an artificial light. NOW,  
12 **THEREFORE, BE IT RESOLVED**, that MUCC work with the Natural Resources Commission or the  
13 Michigan Legislature as necessary to change the regulation to allow deer hunters to use an artificial light  
14 two hours before and two hours after shooting hours while carrying an unloaded firearm or bow and  
15 arrow when traveling on foot to or from their hunting location.

1 **WHEREAS**, the Michindoh Aquifer spans 9 counties in the states of Michigan, Indiana and Ohio; and

2 **WHEREAS**, the waters of the Great Lakes are held in commonality among all the states and provinces  
3 of the Great Lakes Water Compact; and

4 **WHEREAS**, the Michindoh Aquifer is part of the waters of the Great Lakes; and

5 **WHEREAS**, all members of the Great Lakes Water Compact (which includes Michigan, Indiana, and  
6 Ohio) have agreed that all their respective states should be at the table to discuss issues relating to the  
7 waters of the Great Lakes; and

8 **WHEREAS**, the Great Lake states ( which include Michigan, Indiana and Ohio) have joined the Great  
9 Lakes Water Compact and agreed to follow the rules and processes for ensuring the future integrity of the  
10 water of the Great Lakes; and

11 **WHEREAS**, there must be unanimity of states and provinces in the Great Lakes Water Compact in  
12 allowing any large scale use or diversion of the waters of the Great Lakes; and

13 **WHEREAS**, Artesian of Ohio (AOP) has presented a proposal to sell water from the Michindoh Aquifer  
14 to the Toledo Ohio area at and rate of at least 10 million gallons per day (with quoted amount up to 28  
15 million gallons per day); Now,

16 **THEREFORE BE IT RESOLVED**, that MUCC (Michigan United Conservation Clubs) work with the  
17 Great Lakes Water Compact and the states of Michigan, Indiana, and Ohio (who are members of the Great  
18 Lakes Water Compact) to ensure that the rules and processes of the Great Lakes Water Compact be  
19 employed in this large scale use or diversion of water of the Great Lakes; and

20 **BE IT FURTHER RESOLVED**, that MUCC work with the Environmental Protection Agencies of the  
21 States and Provinces of the Great Lakes Water Compact and with the Federal Environmental Protection  
22 Agency to ensure that the waters of the Great Lakes are protected as dictated by the rules and processes of  
23 the Great Lakes Water Compact.

3 two if needed; and  
4 **WHEREAS**, many fisherman who troll the Great Lakes and associated waterways would like to have the  
5 opportunity to put more lines in the water to maximize fishing opportunities; and  
6 **WHEREAS**, there have been concerns in the past to expanding the number of lines for anglers fishing  
7 from the frozen ice, shore or fishing piers as crowding can become an issue; and  
8 **WHEREAS**, the regulation of size, daily bag and possession limits set by the Natural Resources  
9 Commission and also governed by the Great Lakes and Inland Consent Decree would be maintained, even  
10 with a higher rod and line limit; NOW,  
11 **THEREFORE, BE IT RESOLVED**, that Michigan United Conservation Clubs work with the Michigan  
12 Legislature and Michigan Department of Natural Resources to enact legislation to allow the DNR to  
13 expand the number of lines for trolling anglers.

**Title:** **EXPANDED HUNTING OPPORTUNITY WHILE MANAGING FOR A  
BALANCED DEER HERD**

1 **WHEREAS**, Our current deer hunting regulations offer either a single buck tag or a combo tag which  
2 allows for two bucks.

3 **WHEREAS**, Arguably our deer herd is out of balance with the buck-doe ratio being very heavy with  
4 does

5 **WHEREAS**, There is and has been for some time a collaborative effort to revert to the pre-1986 one  
6 buck license. (Eon Green on line petition 2016 which gathered over 10,000 signatures in support)

7 **WHEREAS**, There is a growing trend for Michigan Hunters to travel out-of- state in search of their deer  
8 hunting opportunities which equates to much lost revenue to the State of Michigan.

9 **WHEREAS**, The current "combo" license allows the take of two bucks with exceptions allowed while  
10 utilizing archery equipment to allow 1 buck 1 doe or even 2 does with 100% archery equipment.

11 **WHEREAS**, Michigan comes from a long culture of not shooting does which shows in our current deer  
12 herd with the large imbalance in most areas.

13 **WHEREAS**, The current system requires extra effort from any sportsmen to acquire the legal means  
14 (tags) to harvest a doe with a gun.

15 **WHEREAS**, Michigan has been making efforts with heavy support of sportsmen to increase the age  
16 structure and quality of our deer herd in many Deer Management Units (DMUs) throughout this state.

17 **WHEREAS**, This resolution as detailed below does not "take away" opportunity but rather "adds"  
18 opportunity with a high chance of helping to strengthen our herd while being able to harvest venison.

19 NOW,

20 **THEREFORE BE IT RESOLVED**, That Michigan United Conservation Clubs (MUCC) work with the  
21 Department of Natural Resources (DNR) and the Natural Resource Commission (NRC) to:

22 1) Change the current definition of combo tag to read valid for the take of one buck and one doe  
23 with any legal method;

24 2) Only allow a single buck tag option in areas that require extra herd protection and would  
25 otherwise not allow the take of a doe with any means (such as archery);

26 3) Make available in all other areas either the new combo (both sex) or single buck tag.

27 4) Maintain hunter supported additional requirements in DMUs that have supported such. (Such as  
28 APRs)

29 5) In areas of special management needs such as disease areas or high-density areas additional tags  
30 can be made available per DNR recommendations or mandates

**Title:** **SPORT SHOOTING RANGES PROTECTION MODERNIZATION ACT**

1  
1 **WHEREAS,** Private property, agricultural areas and other public property such as the Department of  
2 Natural Resources shooting ranges and state game areas are limited in access, availability, safety features  
3 and location throughout the state for hunting, competitive and recreational shooting, and other firearm  
4 activities; and  
5 **WHEREAS,** Conservation clubs, sportsmen’s clubs, rod and gun clubs, and other private firearms  
6 ranges (sport shooting ranges) have had substantial increases in memberships and usage by member and  
7 non-member events, and private and public entities (example: law enforcement, DNR hunter safety  
8 education, Whitetails Unlimited, Pheasants Forever, 4 H Shooting Sports, etc). This is due to increased  
9 interest in hunting, competitive and recreational shooting; and  
10 **WHEREAS,** Local, county and state law enforcement agencies use sport shooting ranges for their  
11 firearms training due to updated and current safety features. These clubs and range locations are very cost  
12 effective or free to train and qualify officers with their firearms; and  
13 **WHEREAS,** Existing sport shooting ranges need to expand their real property, update facilities,  
14 buildings and ranges without the fear of excessive and overburdening regulations, ordinances, zoning  
15 changes, and taxes; and  
16 **WHEREAS,** Sport shooting ranges are often being targeted by individuals, local governing boards and  
17 other groups to stop activities or limit access to the facilities. These individuals, local governing boards  
18 and other groups create exorbitant legal and other financial costs to the clubs/ranges to defend against  
19 these nuisance complaints; and

20 **WHEREAS**, Existing and new sport shooting ranges are increasingly being pressured by local  
21 governments, township officials, zoning boards, tax assessors, planning commissions: to wit: increasing  
22 regulations by planning commissions, zoning board changes to current/existing zoning classifications,  
23 township, city, village and other local officials implementing new ordinances and/or now enforcing  
24 previously unenforced local ordinances, excessive regulations, and changing tax formulas and taxes.

25 NOW,

26 **THEREFORE BE IT RESOLVED**, That the Michigan United Conservation Clubs (MUCC) shall work  
27 with the state legislature to pass a law limiting or eliminating new and existing regulatory pressure aimed  
28 at sport shooting ranges via local ordinances, prohibitive zoning changes and regulations, planning  
29 commission issues, regulations and changing tax formulas and taxes on new or expanding sport shooting  
30 ranges: Provided the sport shooting ranges meet or exceed nationally recognized range standards at the  
31 time of development on property they currently lease, own or purchase in the future. (Examples are the  
32 National Rifle Association Range Standards, or National Shooting Sports Foundation range parameters.)  
33 New buildings will meet existing building codes. Remodeled buildings shall meet building codes in  
34 existence when the original structure or structures were built; and

35 **BE IT FURTHER RESOLVED**, That the Legislature update Michigan Law in regards to firearms  
36 ranges, and allow new and existing sport shooting ranges to work under the prior firearms range laws and  
37 noise ordinances AND enact new laws to protect existing ranges from the nuisance complaints, additional  
38 regulatory pressure, excessive local ordinances, prohibitive zoning changes and regulations, planning  
39 commission issues, regulations and taxes on new or expanding sport shooting ranges, and

40 **BE IT FURTHER RESOLVED**, That the Legislature should also enact and/or create civil penalties for  
41 private citizen nuisance complaints made to any governmental entity toward a sport shooting range in  
42 which those complaints or issues are addressed by Michigan Law, or are based in Common Law.

4 are indicative of risk, are unknown factors; and  
5 **WHEREAS**, the potential to harm fisheries and other terrestrial wildlife as well as the issuance of  
6 consumption advisory’s has alerted the public to its danger; and  
7 **WHEREAS**, it has been found in drinking water supplies in some locations of the state; NOW,  
8 **THEREFORE BE IT RESOLVED**, that MUCC support PFAS education for the public and our  
9 affiliates as well as supporting the state agencies to do the necessary research to better address the issue;  
10 and  
11 **BE IT FURTHER RESOLVED**, Be it further resolved that MUCC work with other organizations for  
12 which this is an issue of concern to better facilitate the objective decision making needed to find solutions  
13 to PFAS contamination

1 **WHEREAS**, Current methods utilized to determine our deer herd size, take, etc are largely based on  
2 estimates and voluntary contributions from the sportsperson.  
3 **WHEREAS**, To do our best in managing the deer herd we need to gather accurate information.

4 **WHEREAS**, Wisconsin is a state to which appears to have a good, mandatory deer registration system in  
5 place that could be looked to for ideas.

6 **WHEREAS**, The hunting community commonly down plays the Department of Natural Resources  
7 (DNR) forecasts and field reports of harvest, herd etc as there is little buy in from the general sportsmen  
8 on the methods currently in place in making such predictions or determinations. NOW,

9 **THEREFORE BE IT RESOLVED**, That Michigan United Conservation Clubs work with the DNR and  
10 the Natural Resource Commission to enact a mandatory deer check system that is supported with  
11 penalties for those that ignore this requirement. This system should entertain these or similar steps:

- 12 • Simple call in system with predetermined basic questions such as your ID, animal description,  
13 method of take, area of take and any other simple question that may be useful such as "Do you  
14 hunt out of State and why?"
- 15 • On line system that will complement the call-in system as another means of reporting.
- 16 • Historic drive-in check stations where available that again will maintain the check in requirement.
- 17 • The deer will need to be registered within 24 hours of harvest OR 24 hours of returning home  
18 from camp (to accommodate remote camps where access to phone, internet etc is not reasonable)
- 19 • Impose penalties for those that do not register

1 **WHEREAS**, the Michigan Natural Resources Trust Fund (MNRTF) has proven to be an effective  
2 mechanism for allotting royalty extraction funds through a governing citizens Michigan Natural  
3 Resources Trust Fund Board (MNRTF Board); and



4 **WHEREAS**, these projects are judged against criteria created to best benefit the public lands and the  
5 natural resources from which wealth is extracted, for purposes of acquisition, improvement, and  
6 development of recreation on land held in public trust; and  
7 **WHEREAS**, the premise of the royalty payment is compensation for the extraction of resources from  
8 public lands by benefiting the expansion and conservation of state holdings, and constitute assets placed  
9 in a public trust; and  
10 **WHEREAS** the Michigan State Parks Endowment Fund (SPEF) has no such governance by a citizen  
11 board as constituted in the MNRTF; and  
12 **WHEREAS**, the use of public funds above and beyond the \$500 million cap for the MNRTF constitute  
13 the funding of the SPEF, and by extension should be used for the same long-term priorities of asset  
14 acquisition and capital improvements; NOW,  
15 **THEREFORE BE IT RESOLVED**, MUCC will work to develop a similar governing body for the  
16 SPEF to make decisions as to the disbursement of the fund for acquisition, improvement, and restoration  
17 (capital expenditures) and not for operations (recognizing that any such project will have a certain % of  
18 labor cost and staff time needed above and beyond the normal operating costs of the Division – a % to be  
19 considered by the suggested board as that which is appropriate to the grant proposal).

**Title:** **ONE BUCK PER HUNTER IN EACH PENINSULA**

1 **WHEREAS**, the combination tag can be eliminated and a one buck rule implemented that may earn more  
2 support among the hunting public; and  
3 **WHEREAS**, under this proposal, Michigan deer hunters would be able to purchase both a Lower  
4 Peninsula (LP) buck tag and an Upper Peninsula (UP) buck tag; and

5 **WHEREAS**, the LP buck tag is only valid in the Lower Peninsula, and the UP buck tag is only valid in  
6 the Upper Peninsula; and

7 **WHEREAS**, Michigan deer hunters will still be able to harvest two bucks in Michigan if they choose to,  
8 currently only about 4 percent of hunters do; and

9 **WHEREAS**, this would potentially increase the numbers of Lower Peninsula hunters hunting in the  
10 Upper Peninsula and vice versa; and

11 **WHEREAS**, hunters who tagged out in the Upper Peninsula may then want to buy a tag for the Lower  
12 Peninsula and vice versa; and

13 **WHEREAS**, hunters who hunt both the Lower and Upper Peninsulas can still take a buck in each hunting  
14 zone; and

15 **WHEREAS**, hunters in the Lower Peninsula would more likely hunt in the Upper peninsula for the first  
16 time and vice versa; and

17 **WHEREAS**, this would encourage Michigan's Lower Peninsula hunters to purchase an additional buck  
18 tag for the Upper Peninsula rather than go to a neighboring state to shoot an additional buck; and

19 **WHEREAS**, this new license system should boost the economy of the Upper Peninsula; and

20 **WHEREAS**, does can be managed separately throughout the state where needed; and

21 **WHEREAS**, the doe harvest should increase significantly in both hunting zones where allowed by  
22 limiting hunters to one buck per peninsula; and

23 **WHEREAS**, deer hunters will continue to be involved in the management of Michigan's deer herd for  
24 quality, not quantity; and

25 **WHEREAS**, hunters would be more likely to harvest a doe instead of harvesting a young buck for meat;  
26 and

27 **WHEREAS**, young bucks would have a chance to grow and does would be more likely harvested; and

28 **WHEREAS**, this proposal would not change any antler point restrictions (APR) already in place on the  
29 first buck tag, but over time this new license structure could eliminate the need for antler point restrictions  
30 in the future as people will be restricting their harvest voluntarily; NOW  
31 **THEREFORE BE IT RESOLVED**, that Michigan United Conservation Clubs (MUCC) work with the  
32 Department of Natural Resources (DNR) and Natural Resources Commission (NRC), and the Michigan  
33 Legislature if necessary to simplify and restructure the deer license to include one LP buck tag, and one  
34 UP buck tag eliminating the need for the combo deer license; and  
35 **BE IT FURTHER RESOLVED**, that the DNR and the NRC manage Michigan’s deer herd for health,  
36 buck to doe ratio, and quality and not quantity; and  
37 **BE IT FURTHER RESOLVED**, that the DNR and NRC provide sufficient antlerless tags available to  
38 meet the needs of managing the deer herd in that Deer Management Unit (DMU).

1 **WHEREAS**, Michigan United Conservation Clubs (MUCC) has historically sought to ensure that new  
2 and emerging technologies used in the pursuit of fish and game and outdoor recreation will not adversely  
3 affect our outdoor heritage, and  
4 **WHEREAS**, the use of unattended cameras (a.k.a. Trail Cameras) on public lands has increased  
5 significantly each year as both their cost and size have further been reduced, and  
6 **WHEREAS**, an increasing number of reports have emerged in recent years that unattended and  
7 unidentified cameras are being observed in such places as public access sites, beaches, and recreation  
8 trails and other locations where their use would not appear to be intended as an aid in the monitoring of  
9 wild game, and

10 **WHEREAS**, the cost and size of these cameras is likely to continue to decrease as their technological  
11 capabilities increase which could potentially result in their further proliferation on public lands to a point  
12 where the outdoor experience becomes compromised, and  
13 **WHEREAS**, this rise in number and distribution of unattended cameras increases the potential for  
14 incidents of inappropriate use which could negatively affect the public image of hunters and other outdoor  
15 recreationalists, and  
16 **WHEREAS**, this increasing sense of “being watched” can undermine the quality of the outdoor  
17 experience on our public lands. NOW,  
18 **THEREFORE BE IT RESOLVED** that Michigan United Conservation Clubs (MUCC) work with the  
19 Michigan Department of Natural Resources to develop a policy for the use of unattended cameras (a.k.a.  
20 Trail Cameras) on State of Michigan-managed lands which seeks to limit their number and duration of  
21 use, and further require that each camera deployed include the name and contact information of the  
22 owner/user, and  
23 **BE IT FURTHER RESOLVED** that unattended cameras used for DNR-sponsored, or DNR-approved  
24 research shall be subject to a separate policy regarding their us

1 **WHEREAS**, Indiana has been using center fire rifles in the entire state the last few hunting seasons  
2 without a major safety problem occurring; and  
3 **WHEREAS**, here in Michigan, the Natural Resources Commission (NRC) adopted several calibers of  
4 rifles using straight-walled cartridges in 2014 for the limited firearm deer zone (formerly the shotgun  
5 zone), which was reauthorized in 2017; and

6 **WHEREAS**, most modern muzzleloaders have a 200-yard range which are allowed in the limited firearm  
7 deer zone in Michigan as well; and  
8 **WHEREAS**, currently, center fire rifles can be used for coyote, fox, woodchuck and other small game in  
9 the limited firearm zone; and  
10 **WHEREAS**, current regulations in Michigan for the rest of the state should apply to the limited firearm  
11 deer zone; NOW,  
12 **THEREFORE BE IT RESOLVED**, that Michigan United Conservation Clubs (MUCC) work with the  
13 Department of Natural Resources (DNR) and the Natural Resources Commission to change Michigan's  
14 limited firearm deer zone to have the same firearm restrictions and regulations as the rest of Michigan.

1 **WHEREAS**, Under Current State of Michigan law firearms, particularly handguns, must be registered to  
2 an individual and cannot be registered in the name of an organized, incorporated club; and  
3 **WHEREAS**, A club may purchase firearms, but are unable to legally register them under current state  
4 law; and  
5 **WHEREAS**, As an individual who has firearms owned by a club, registered in their name may die or  
6 relocate; and  
7 **WHEREAS**, This situation limits the use of the firearm for club functions, and transportation and  
8 specifically return to manufacturer for maintenance and repair; and  
9 **WHEREAS**, The current status of the law places undo liability on the individual in whose name the  
10 firearms are registered; NOW

11 **THEREFORE BE IT RESOLVED**, that Michigan United Conservation Clubs work with the Federal  
12 Government, Michigan Legislature and the Governor’s office to enact legislation that will legally allow  
13 organized, incorporated sportsmen’s clubs and or shooting clubs to register firearms owned by the club

**Title:** **RESOLUTION TO ASSURE FAIR AND EQUITABLE DISTRIBUTION  
OF FUNDS DERIVED FROM GAS TAX**

1 **WHEREAS**, under MCL Section 324.020 (1) the Recreation Improvement Account is established as an  
2 account within the Legacy Fund, and  
3 **WHEREAS**, under Section 324.020 (2) The Recreation Improvement Account shall consist of both of  
4 the following: (a) All money in the Recreational Improvement Fund, formerly created in Section 71105,  
5 immediately prior to the effective date of the amendatory act that added this section, which money is  
6 hereby transferred to the Recreation Improvement Account, and  
7 **WHEREAS**, under (b) the revenue (is derived) from the following sources: (i) Two percent of the  
8 gasoline sold in this state for consumption in internal combustion engines. And (ii) Other revenue  
9 provided by law, and  
10 **WHEREAS**, under MCL Section 324.71101 (e) Recreational Projects are defined to mean, in addition  
11 to the activities provided for in this part, the construction, maintenance, and operation of trails and  
12 associated facilities that may be used by off-road vehicles, cross country skiers, horseback riders, and  
13 hikers, and inland lake cleanup grants as provided by part 309, and  
14 **WHEREAS**, the Recreation Improvement Account (Fund) distribution matrix currently directs that 80%  
15 of said funds is dedicated for use in Waterways Recreational Projects, 14% is dedicated for use in  
16 Snowmobiling Recreational Projects and the remaining 6% is dedicated for all other uses (including  
17 motorized and non-motorized activities), and

18 **WHEREAS**, All-terrain Vehicles (ATVs) and Off-Road Vehicles (ORVs) by unit sales and gas tax  
19 revenue derived for the Recreational Improvement Account, now exceeds that produced by recreational  
20 watercraft (vessels) and snowmobile, and  
21 **WHEREAS**, cross country skiers, horseback riders, hikers and bicyclists contribute zero direct revenue  
22 towards the Recreational Improvement Account, and  
23 **WHEREAS**, with expanded opportunity for recreational motorized riding along county, state forest,  
24 federal forest roads and limited access to highway trunk lines for connection, that there is certainty as to  
25 an increased need of dedicated funds for remuneration for maintenance and repair of the aforementioned  
26 roadways beyond the scope of current funding sources. NOW,  
27 **THEREFORE BE IT RESOLVED**, that Michigan United Conservation Clubs support and initiative to  
28 change the Michigan Recreational Improvement Account matrix of fund distribution to include only  
29 those entities that directly contribute to the account via the gas tax, and  
30 **BE IT FURTHER RESOLVED**, that the Michigan Legislature resolves to also amend the Michigan  
31 Improvement Account matrix of fund distribution to establish as fair and equitable sharing of said funds  
32 proportionate to the current economic impact by unit sales, and/or permit (license) unit sales, and/or  
33 impact on tourism for the State of Michigan, and  
34 **BE IT FURTHER RESOLVED**, that a percentage of all proportionate designated funds shall be put  
35 aside for all related remuneration needs and eligible for application and use by those county, state and  
36 federal and highway management agencies affect

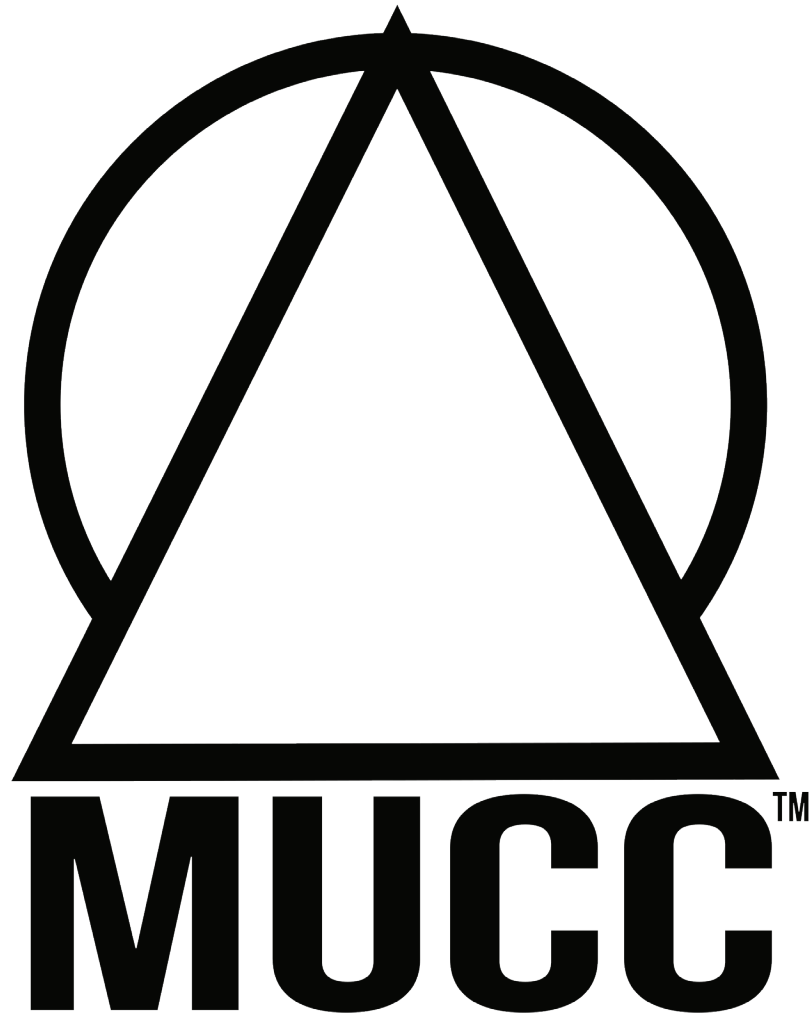
