


Conservation Organizations

Financial Assistance

For Sustainable Forest Management in Michigan



Michigan's Forestry Assistance Program exists to increase active and engaged forest management on non-industrial private forestland. Forestry Assistance Program foresters, employed by local Conservation Districts, provide education, outreach, and one-on-one technical assistance to family forest owners. A survey conducted by Michigan State University of family forest owners concluded that roughly 20% of the nine million acre resource is actively managed.

Conservation Districts

Michigan's 78 Conservation Districts provide natural resource management services to help citizens conserve their lands and our environment for a cleaner, healthier, economically stronger Michigan. Districts provide quality and cost-effective conservation technical assistance and information to citizens to provide conservation improvement to the land and foster understanding and wise management of our natural resources. Districts provide a number of assistance programs, including tree sales, no-till drill rental for native grasses and/or food plots, hand-held broadcast seeders for native seed, tree planter rental, technical habitat assistance, and educational presentations. USDA Natural Resources Conservation Service (NRCS): Farm Bill Programs

Environmental Quality Incentives Program (EQIP)

A voluntary conservation program that provides financial and technical assistance to landowners to implement conservation practices on eligible agricultural and non-industrial private forestland, EQIP provides financial assistance to plan and implement conservation practices that address natural resource concerns to improve forest health, wildlife habitat, soil, water, and air quality. Priorities include habitat restoration for at-risk wildlife species, reduction of nonpoint source pollution (i.e., sediments, nutrients) entering surface and groundwater, and carbon storage and sequestration. Conservation Stewardship Program (CSP)

A voluntary program that helps landowners maintain and improve their existing conservation systems and adopt additional conservation activities to address priority resources concerns, and meet the landowners objectives. For additional information, visit www.nrcs.usda.gov.

Forest Resources Division, Forest Stewardship Program

The Forest Stewardship Program helps landowners manage, protect, and enjoy their forest. The Forest Stewardship Program connects landowners with a professional forester to develop a Forest Stewardship Plan to help them achieve their personal goals for their land. The program is a partnership between the U.S. Forest Service (USFS), the Department of Natural Resources (DNR), and private sector foresters and wildlife biologists. Since 1991, more than 5,300 landowners in Michigan have developed their own unique Forest Stewardship Plan to help them manage, protect, and enjoy over 850,000 acres of forestland.

Each Forest Stewardship Plan is a custom plan that describes the landowner's personal goals, unique forest resources, and suggested management activities. There are 120 certified plan writers with several available to write plans in every county in Michigan. DNR Service Foresters review Forest Stewardship Plans to ensure that the plans meet program standards.

The Forest Stewardship Program also provides financial assistance to lower the cost of a Forest Stewardship Plan. A partial cost share of \$200 per plan, plus \$0.50 per acre up to \$2,500 for parcels ≥ 20 acres, is available throughout the year. The cost share is paid through grants to the certified Plan Writers to minimize the application and payment process for landowners. Fees for plan writing will vary between Plan Writers.

Commercial Forest Program

The Commercial Forest (CF) Program provides a significant property tax reduction to private forestland owners as an incentive to retain and manage their forestland for long-term timber production in support of the state's forest products industry. The CF Program is governed by the CF statute and administrative rules.

Wildlife Division, Private Lands Program

The Private Lands Program (PLP) focuses on providing private landowners with resources to create and manage habitat to benefit a variety of wildlife. With additional funding from the hunting license restructuring, the Department of Natural Resources is expanding efforts to assist hunters and wildlife on private lands. PLP staff provide technical and financial assistance to eligible landowners for habitat improvements for targeted species and habitats in priority areas.

U.S. Fish & Wildlife Service

Partners for Fish and Wildlife (PFW) Program

PFW focuses on improving habitat for federal trust resources: migratory birds, federally-listed endangered or threatened species, and interjurisdictional fish. PFW also includes restoration of grasslands, streams (both in the channel and within the riparian corridor), and specific habitats used by federally-listed endangered or threatened species. PFW encourages working together in a voluntary manner with private landowners to restore and enhance fish and wildlife habitat. Many landowners contribute funds for permits or construction and in-kind services, such as labor to prepare seed beds and seed disturbed areas. Landowners are required to sign an agreement to leave the project in place on their property a minimum of 10 years. Landowners are responsible for project maintenance.

Qualified Forest Program

The purpose of the Qualified Forest Program is to encourage private forestland owners to manage their land in an economically viable and environmentally sustainable manner. Landowners receive an exemption from local school operating taxes and/or exemptions from the uncapping of the taxable value of the property in the event of a change in ownership.
